Interpretation and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or plural.

Definitions

For the purposes of these Terms and Conditions:

- **“Company”** (referred to as either “the Company”, “We”, “Us” or “Our” in this Agreement) refers to Library Cats Publishing House CIC.
- **“Country”** refers to the United Kingdom.

Cookies

Library Cats Publishing House CIC does not utilise cookies within this website. No personal data will be processed outside the EEA. All information you provide to us is stored, usually within the UK or the EEA, on secure servers hosted by us or third parties providing hosting or other services for us. We store application details including personal, sensitive data in electronic forms, these are kept on our secure document-based database, fully secure and safe to industry standard. You must seek the other person's agreement to the sharing and processing of their personal information in line with this policy before disclosing their information to us. The use of any personal information you provide to us via our website will be in accordance with this policy and any applicable website pages.

Data Retention

Your data will not be retained for more than 5 years from the last point at which we provided any services or otherwise engaged with you, and it is our policy to store your personal data for as long as it is necessary for us to comply with our legal obligations and for our legitimate business interests. However, we may retain data for longer than a 5-year period where we have a legal or contractual obligation to do so. Thus, we reserve the right to delete/use personal information/data after this period of time has elapsed. If you think that we should delete your personal data sooner, please notify us in writing of your reasons.

Your personal information may be used by us for the following purposes:

- Customising our website for you.
